Membership Terms & Conditions

I understand that I am agreeing to pay a membership fee for golf, and/or facility privileges to The Club at Lake Tillery. I am aware that my membership is non-refundable and non-transferable for any reason and does not grant me any propriety rights of ownership to country club, nor does my acceptance as a member and payment of the membership fee guarantee future membership rights to The Club at Lake Tillery.

Effective management of accounts receivable at the country club is important and necessary to protect the rights and privileges of every member. Accordingly, any member's account that becomes past due after 30 days will incur a 1.5 % service charge per month for any outstanding balance.

Should a past due not be paid in full by the end of the following month the account will be considered delinquent and Member privileges may be suspended/revoked until paid in full. By signing membership application, you agree to pay for all charges billed to your account, including monthly dues, golf fees, merchandise, and food & beverage purchases/charges in the indicated prescribed time frame.

Acceptance

I hereby acknowledge that the use of country club facilities and any privileges or services pertaining to membership is undertaken with knowledge of risk of possible injury. If an accident should transpire, I hereby accept all risk of injury to myself, my guests, and family sustained while using the country club facilities; or involved in any event or activity pertaining to membership at the country club. Medical Inactive Status

A Medical Inactive Status is available with a written and signed note from your physician.

Dress Code

Golfers are required to wear appropriate golf attire. Tank tops, tee shirts, blue jeans, athletic pants and swim wear **are not** permitted. Metal spikes **are not** permitted on the golf course or in the clubhouse.

Resignation

In the event you decide to resign your membership at any given time, you will be fiscally responsible for the remaining balance and any other charges/amount owed to The Club at Lake Tillery, LLC. All resignations must be in written form and they must be given 30 days in advance. Any member who resigns or is terminated from the country club will not be eligible for reinstatement for membership until one year from the date of resignation.
